

## **Covid Policy Terms & Conditions**

We welcome you back to SWIG events in person, so you can socialise, try out new kit on display and enjoy the whole the live event experience. We are working with every venue to put in place the best measures possible to reduce the risk of Covid-19 during your visit. This includes cabaret style room layouts to give people more space, hand sanitiser stations, increased ventilation, refreshments served by staff to reduce handling and no open lunch buffets for the time being.

We strongly recommend that everyone attending takes a LFT within 24 hours before an event and only attend if the result is negative, to protect other delegates and keep our events safe.

Please note that any interaction with the general public poses an elevated risk of being exposed to COVID-19 and although we are taking all reasonable precautions to keep our attendees and staff safe we cannot guarantee that you will not be exposed while in attendance at the event. For your safety and that of other attendees, we encourage you to follow our safety policies, as well as local laws and restrictions.

## **Customer Safety**

We aim to keep everyone Covid safe. We ask that you support us by following these conditions as part of your registration process:

- Do not travel or attend if you are feeling unwell, have a temperature or any cold/covid systems, or have been in close contact with anyone that has had a positive test within the previous 5 days
- Do not travel or attend in breach of government track and trace guidelines at the time of the event https://www.gov.uk/coronavirus.
- We will supply a record of all attendees for track and trace if required. All visitors will be required to check-in on arrival.
- We ask visitors to make use of hand sanitizer stations provided, regular hand washing and reduced physical contact throughout the event.
- The space will be well ventilated and we ask that people respect social distancing.
- Mask wearing is recommended particularly in crowded areas.

## Staff and venue safety:

We will work closely with the venue and all suppliers to create a safe environment with appropriate standards of hygiene, space management, ventilation, and contact safety as per government guidelines.

- Good ventilation: The conference room will be well-ventilated with fresh air through open windows and doors (weather permitting), or fresh air circulation from air conditioning.
- Food hygiene: Refreshments will be served by venue staff to minimise contact and queues managed appropriately
